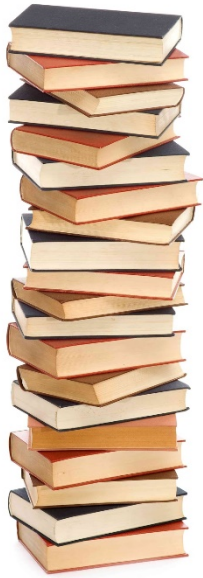

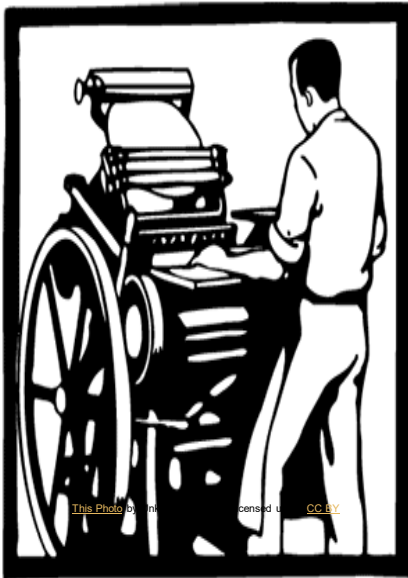

MANUSCRIPT SUBMISSION AUTHORIZATION & CONFIDENTIALITY AGREEMENT

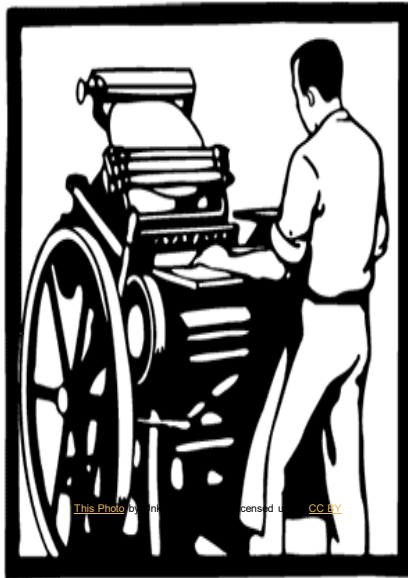

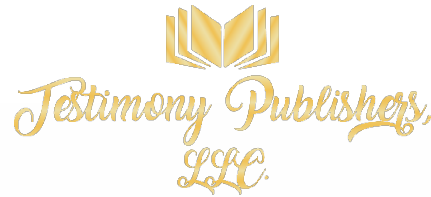

OUR REVIEW PROCESS

Testimony Publishers, LLC., having an address of P.O. BOX 2869, Jackson, WY 83001, hereby agrees to review author's manuscript based on certain criteria, our current need, and our availability to commit to the necessary time and attention to manuscript development and book publishing. Manuscripts that contain gratuitous violence and sexual intercourse or promotes theories that are hostile towards individuals or groups of people based on race, religion, gender, or socioeconomic status will be rejected.

Assuming the author's manuscript is acceptable in accordance with the aforementioned terms, we must still determine whether it satisfies our current genre need. For example, if your manuscript is a cookbook, and we have recently accepted a number of these same types of manuscripts, we may reject it. A rejection of this sort is by no means a statement or opinion by us on the quality of the author's work. There may, however, be an opportunity, at a future date, to publish the author's manuscript as a compilation with other contributing authors of the same genre.

We may also reject the author's manuscript if we believe the quality to be such that it would not be economically possible for us to edit the work to comply with our quality standards. The author's manuscript must be, in our opinion, of sufficient quality that we can readily publish it with a standard amount of editing. Also, note that we will not review incomplete manuscripts.

Finally, please note that if we do accept your manuscript for publication, it is in no way an assessment by us or a prediction that your book, once published, will be commercially successful. Our acceptance of your manuscript simply indicates that we would be proud to have your book as part of our published catalogue of works, and to distribute it nationally and internationally. Please be mindful of this when deciding whether to invest time and money into publishing your manuscript.
